Halter points are halter points whether grand and reserve or other. [Lonnie](#) - they already won the class. The points are for the division. [Lee](#) - may as well remove max on classes and keep it open to as many classes as they want?!
- Lee and Kenny then went over how the halter points work for the year end awards.
- Year end halter points - will be total points on the horse.
- Bobbi Pommerening will call Bill Bachman and find out about the pattern for the stick horse equitation.
